## **OPEN LETTER TO JOHN CONYERS**

Honorable John Conyers Chairman, House Judiciary Committee

## **Chairman Conyers:**

I write to urge your immediate action on House Resolution 799, Articles of Impeachment against Vice President Cheney. Abundant evidence already in the public domain indicates he has violated his Oath of Office and is guilty of "high crimes" against the Constitution of the United States.

In addition to the three Articles authored by Rep. Like millions of Americans, I am outraged by the crimes of this administration, which have left our nation weaker and less secure in every sense. Most tragic has been the loss of moral credibility--the shaming of our national name. This ruination cannot be denied by simply "moving on" as though treason and crimes against humanity were merely "business as usual" of no lasting consequence. If allowed to stand unpunished, the flagrant abuses of this Vice President will become a precedent for future abuses of the Constitution and the American people that one shudders to imagine.

More immediately, impeachment of the Vice President may well prevent a needless and catastrophic war of aggression against Iran, the pain of which would spare no one.

Speaker Pelosi and House leaders who cynically refuse to uphold their oaths of office on grounds that impeachment "would be a distraction" from short-term party goals or because "we don't have the votes" have compromised themselves, betrayed the Constitution and deserve the ignominy in which future generations will hold them. This is not about partisan politics. This is about salvaging the soul of our nation, the very idea of the United States of America. It is about proving to a wronged, wary world that we are unwilling to be complicit in a brutal imperial project, that once awoken we will act in solidarity with humanity, without fear. What matters, what will matter to our children, is

that the attempt is boldly made--whatever the odds or forces arrayed against it--to serve justice and preserve the Republic.

Please honor the heroic efforts of Rep. Kucinich and your own legacy of courageous truth-telling by pursuing these Articles and bringing them to the floor of the House for debate before the world.
